**Terms & Conditions: -**

1. Bid shall be submitted online only through <http://eproc.rajasthan.gov.in>. The Bid documents can be downloaded from this web site.
2. **Bidder should be registered with GST act. The copy of GST Registration shall have to be uploaded in tendering.**
3. **The Bid Price shall be inclusive of all taxes except GST, which will be payable at applicable rate.**
4. No physical/ offline Tender/ bid shall be accepted.
5. The Bidder must have sufficient experience of execution of similar type of works in Govt. department / Public Enterprises.
6. The Tender cost & Earnest Money shall be in the form of Demand draft or Banker cheque of scheduled Bank drawn in favour of Accounts Officer (T&C), RRVPNL Jodhpur payable at Jodhpur for works mentioned at S. No. 01 to 05, Accounts Officer (T&C), RRVPNL Jaisalmer payable at Jaisalmer for works mentioned at S. No. 06 to 06, Accounts Officers (T&C), RRVPNL, Barmer payable at Barmer for works mentioned at S. No. 07 to 08, and Accounts Officers (T&C), RRVPNL, Sirohi payable at Sirohi for works mentioned at S. No. 09 to 11 shall be submitted offline/ manually to scheduled date & time in the office of the XEN (Civil) Jodhpur for S. No. 01 to 05, XEN (Civil) Jaisalmer for S. No. 06 to 06, XEN (Civil) Barmer for S. No. 07 to 08, & XEN (Civil), Sirohi Goyali Road, Sirohi for S. No. 09 to 11.
7. The Bidder enlisted in RVPN, shall deposit concessional earnest money @1/2% of the estimated cost, while the bidders registered in 'A' & 'AA' class in other central/state/undertaking PSU's etc shall deposit concessional earnest money @1% of the estimated cost. However contractor may adopt option for exemption of bid security with submitting form of Bid-securing declaration in enclosed standard format as per RVPN F&R No. 1390 dated 28.01.2021 on non-judicial stamp paper worth rupees 50/- only. But, in case of forfeiture as per rules, full normal earnest money (i.e. @ 2%) shall be forfeited.
8. The processing fee shall be in form of demand draft/ Banker cheque of Scheduled Bank drawn in favour of Managing Director, RISL Jaipur payable at Jaipur and shall be offline/ manually submitted in the office of the Executive Engineer (Civil), with Tender Cost & Earnest Money as above up to scheduled date & time.
9. On award of contract, the work should have started within 15 days; otherwise work will be treated as withdrawn.
10. The undersigned reserves right to cancel the BID without assigning any reasons to the bidder or anyone else.
11. The water & electricity shall be arranged by the bidder at his own source.
12. All Taxes Payable, if any, under the contract or laid down by Government from time to time, shall mandatory to be paid by the bidder as per prevailing rules.
13. The bidder shall have to submit a certificate that he has an establishment covered under the provision of EPF Act. 1952 and having a separate registration with P.F. commissioners. In

- absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employees engaged by him for the said work) with RRVPNL, along with details of such employees and deduction as per RVPN CPF rules shall be made from his bills/ Security deposit.
14. The bidder should inspect the site of work prior to filling the tender. The work may be carried out in charged Sub Station Yard. The contractor should take all precaution & safety measures at his level to avoid any accident/ miss happening & damages, the complete liability shall be rest with respective contractor.
  15. The Quoted rates are valid for 90 days after the date of opening of tender / Bid.
  16. Conditional tender & casual letters sent by the contractors will not be accepted.
  17. Any representation after opening of tender shall be ignored. These parties may be debarred from tendering in future for a specific period. Their earnest money in such cases will stand forfeited.
  18. Bidders are requested to read the instruction in the tender documents/ bid before submitting the tender/ bid online.
  19. The test moulds for respective work shall be transported by contractor to Quality Control Lab, Jodhpur for testing at his own cost.
  20. The Qualified Engineer / Supervisor to be deputed by contractor at Work Site.
  21. Looking to the urgency of work & matching the commissioning Schedule of GSS, the contractor may be asked to complete any part/ whole work on priority and the contractor will complete the said part as per requirement of department without any compensation.
  22. The above terms & condition of the bids may also be seen on RRVPNL, website [www.rvpn.co.in](http://www.rvpn.co.in) along with bid invitation notice.
  23. To participate in online tenders, bidders will have to procure digital signature certificate using which they can sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency or they may contact procurement Cell, Department of IT & C. Govt. of Rajasthan. Yojna Bhawan, Tilak Marg, C-Scheme, Jaipur contact No. 0141-4022688 for further assistance. However, the physical signature, wherever required by the department, are to be made essentially, otherwise their bids are liable to be rejected.
  24. Training for the bidders on the usage of E - Tendering system is also being arranged by RISL on regular basis. Bidders interested for training may contact e-Procurement Cell RISL for booking the training slot.
  25. The tender cost shall not be refunded in any case.
  26. Bid security should be taken in accordance of provision of Rajasthan Transparency in Public and Procurement Act.
  27. All Rules & Regulations of Rajasthan Transparency in Public and Procurement Act 2012 and Rajasthan Transparency in Public and Procurement Act 2013 are applicable in above Tenders.
