Tender shall be submitted online only through eproc.rajasthan.gov.in. the tender documents can be downloaded from this web site. The tender documents can be seen in respective Division offices in office hours.

1. **Tender should be registered with GST. The bidder must submit the GST Registration certificate & copy of latest filed GST return by bidder as documentary evidence to ensure active GST registration status of bidder at the time of bidding and the status of GST Registration Number and GST returns of bidder may also be checked on the GST Portal by procuring authority. The copy of GST registration shall have to be uploaded in tendering.**
2. No physical / offline tender / bid shall be accepted.
3. **The contractor except registered contractor in RVPN must have sufficient experience of execution of similar type of works in Govt. department/Public enterprises. He shall also upload his performance report, list of works executed during last five years.**
4. Work mentioned at S.No.01 to 05 the earnest money (**Bid security declaration**) & tender cost shall be in the form of Demand Draft or Banker Cheque of schedule bank drawn in favour of Accounts Officers (T&C) RVPN payable at Bikaner, S.No.06 to 10 the earnest money (**Bid security declaration**) & tender cost shall be in the form of Demand Draft or Banker Cheque of schedule bank drawn in favour of Accounts Officers (T&C) RVPN payable at Hanumangarh and S.No.11 to 17 the earnest money (**Bid security declaration**) & tender cost shall be in the form of Demand Draft or Banker Cheque of schedule bank drawn in favour of Accounts Officers (T&C) RVPN payable at Ratangarh shall be submitted offline / manually in the office of the up to schedule date and time. EMD will be as per rules.
5. **The processing fee of Rs.500/- & 1000/- respectively in the form of Demand Draft / Banker Cheque of schedule bank drawn in favour of Managing Director, RISL payable at Jaipur and shall be offline / manually submitted in concerned office of the Executive Engineer (Civil), RRVPNL, Bikaner /Hanumangarh/Ratangarh up to schedule date and time.**
6. On award of contract the work should have started within 15 days otherwise work will be treated as withdrawn.
7. The undersigned reserves right to cancel the BID without assigning any reasons to the bidder or anyone else.
8. The rate quoted will be valid for 90 days from the date of opening of tender/bid.
9. The water and electricity shall be arranged by the bidder at his own source.
10. **The bidder shall have to submit a certificate that he has an establishment covered under the provision of EPF Act 1952 and having a separate registration with P. F. Commissioners. In the absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employees engaged by him for the said work) with RRVPNL along with details of such employees and deductions as per RVPN CPF rules shall be made from his bills / security deposit.**
11. Conditional tender & casual letters sent by the contractors will not be accepted.
12. Any representation after opening of tender shall be ignored. These parties may be debarred from tendering in the future for a specific period. Their earnest money in such cases will be stand forfeited.
13. The above terms & conditions of the bids may also be seen on RRVPNL website www.rvpn.co.in along with bid invitation notice.
14. To participate in online tenders, bidders will have to procure digital signature certificate using which they can sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency or they may contact Procurement Cell, Department of IT & C. Govt. of Rajasthan, Yojana Bhawan, Tilak Marg, C-Scheme, Jaipur contact No. 0141-4022688 for further assistance.
15. The bid price shall be inclusive of all taxes except GST, which will be payable at applicable rate by RVPN Deptt.
16. The test moulds for respective work shall be transported by contractor to quality control lab Bikaner for testing at his own cost.
17. Looking to the urgency of work and matching the commissioning schedule of GSS, the contractor may asked to complete the any part of work on priority and contractor will complete the said part as per requirement of department without any compensation.
18. Temporary approach for construction, hutments for working labour etc. re to be constructed by the contractor at his own cost & no payment shall be admissible for this.
19. The tender will governed as per Rajasthan Transparency in public procurement rules 2012 & 2013
20. Bidders are requested to read the instruction in the tender documents/bid before submitting the tender/bid on line.
21. Training for the bidders on the usage of e-tendering system is also being arranged by RISL on regular basis. Bidders interested for training may contact e-Procurement Cell RISL for booking the training slot.
22. The bidder should inspect the site of work prior to filling the tender. The work may be carried out in charged Sub station and yard. The contractor should take all pre-cautions & safety measures at his level to avoid any accident miss-happening & damages to Nigam's property. In case of any accident mis-happening and damages, the complete liability shall be rest with respective contractor.
23. The qualified Engineer/Supervisor to be deputed by contractor at work site as the class of contractor.
24. Bid security (**Bid security declaration**) should be taken in accordance of provision of Rajasthan Transparency in Public and Procurement Act.
25. The tender cost shall not be refunded in any case.
26. For work at S No 10 & 16, only dealers of authorized manufacturers are entitled to participate in this tender, they can participate without the contractor registration
