
**Terms & Conditions: -**

1. Bid shall be submitted online only through <http://eproc.rajasthan.gov.in>. The Bid documents can be downloaded from this web site.
2. **Bidder should be registered with Service Tax department. The copy of Service Tax Registration shall have to be uploaded in tendering.**
3. No physical/ offline Tender/ bid shall be accepted.
4. The Bidder must have sufficient experience of execution of similar type of works in Govt. department / Public Enterprises.
5. The Tender cost & Earnest Money shall be in the form of Demand draft or Banker cheque of scheduled Bank drawn in favour of Accounts Officers (T&C), RRVPNL, Jodhpur payable at Jodhpur for works mentioned at S. No. 01 to 02, Accounts Officer (T&C), RRVPNL Bhadla payable at Phalodi for works mentioned at S. No. 03 to 03, Accounts Officers (T&C), RRVPNL, Barmer payable at Barmer for works mentioned at S. No. 04 to 05, Accounts Officer (T&C), RRVPNL, Kankani payable at Jodhpur for works mentioned at S. No.06 to 15, and shall be submitted offline/ manually in the office of the Executive Engineer (Civil), RRVPNL, N.P.H., Jodhpur up to scheduled date & time for S. 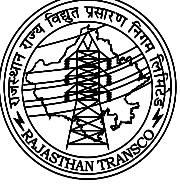
the Executive Engineer (Civil), with Tender Cost & Earnest Money as above up to scheduled date & time.

8. On award of contract, the work should have started within 15 days; otherwise work will be treated as withdrawn.
9. The undersigned reserves right to cancel the BID without assigning any reasons to the bidder or anyone else.
10. The water & electricity shall be arranged by the bidder at his own source.
11. All Taxes Payable, if any, under the contract or laid down by Government from time to time, shall mandatory to be paid by the bidder as per prevailing rules.
12. The bidder shall have to submit a certificate that he has an establishment covered under the provision of EPF Act. 1952 and having a separate registration with P.F. commissioners. In absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employees engaged by him for the said work) with RRVPNL, along with details of such employees and deduction as per RVPN CPF rules shall be made from his bills/ Security deposit.
13. The bidder should inspect the site of work prior to filling the tender. The work may be carried out in charged Sub Division and Yard. The contractor should take all precaution & safety measures at his level to avoid any accident/ miss happening & damages, the complete liability shall be rest with respective contractor.
14. The Quoted rates are valid for 90 days after the date of opening of tender / Bid.
15. Conditional tender & casual letters sent by the contractors will not be accepted.
16. Any representation after opening of tender shall be ignored. These parties may be debarred from tendering in future for a specific period. Their earnest money in such cases will stand forfeited.




