**The rates as per this Circular are as follows :-**

1. For first 1500 Kms or less, Rs. 20000/- Per Month (Service tax extra if applicable)
2. For additional running of Vehicle (more than 1500 Kms) the rate payable @ Rs 7.25 Per Km as per rules.
3. Hired Vehicle shall be used anywhere as per jurisdiction of the office where deployed, in case of night halt other than that of head quarter, a sum of Rs. 200/- Per night shall be paid for the driver.
4. The maximum ceiling of Rs. 25075/- Per Month (Service tax extra if applicable) for 2200 Kms for office having jurisdiction of more than one district.
5. All taxes except toll tax shall be borne by the individual/ contractor/ firm.
6. Reimbursement of toll tax paid by the individual/ contractor/ firm shall be made on production of receipt of payment of toll tax.

**Other conditions shall be as under:-**

1. Vehicle shall not be more than 6 year old. Only vehicles with taxi permit having valid documents shall be considered.

2. All types of liabilities of Vehicle will be borne by the contractor / service provider / individual e.g. taxi permit, insurance fitness, registration, pollution certificated etc.
3. The Rates / Prices are inclusive of all taxes, duties, R&M charges of Vehicle, contribution to CPF/EPF ESI & other liabilities except Service Tax if applicable.
4. Income Tax & other taxes will be deducted a source by the Nigam.
5. The vehicle is to be hired for the period 1Year. Bill is to be submitted monthly and payments shall be arranged on monthly basis.
