NOTICE INVITING TENDER No.10/2017-18

1. The limited tenders are invited for the work "Transportation of M.S. Rod 40 MM earthing material from ACOS, Heerapura, Jaipur to 132 KV GSS, Nanta, Kota including loading, un-loading, stacking and transit insurance" as detailed in the G-Schedule which shall be received up to 3.00 PM on dt. 09.05.2017 and will be opened on the same day at 4.00 PM in the presence of the tenderers who wish to be present at that time.
2. The tenders received after the scheduled time may not be accepted & if delivered after that time are liable to be rejected.
3. The tenders should be addressed to the **Superintending Engineer (T&C), RAJASTHAN RAJYA VIDYUT PRASARAN NIGAM, Kota** & placed in a cover super scribed as "Tender for the work of Transportation of M.S. Rod 40 MM earthing material from ACOS, Heerapura, Jaipur to 132 KV GSS, Nanta, Kota including loading, un-loading, stacking and transit insurance -" due on 09.05.2017.
4. Only those firms who are having experience of transportation work are entitled for participate in tendering.
5. Tender specifications can be obtained on any working day from this office by depositing the requisite tender cost. The tender cost and EMD will be deposited through Bank Draft/Bank Guarantee in favor of AO (T&C) RVPN, Kota. The tender specification obtained from this office by providing supporting documents for eligibility participating in the tender, failing which the tender will liable to rejection.
6. The conditional tenders will not be accepted/considered.
7. The rates so offered will remain valid for a period of 120 days from the date of opening of tenders.
8. The rates should be including all taxes, transit insurance, loading, un-loading, stacking etc. for complete job.
9. The rate should be quoted for complete work, firm in all respect without any price variation including all taxes, Service taxes & duties as applicable from time to time. Safe execution of work shall rest with the contractor.
10. All the charges for road permit and other related taxes will be borne by the firm at his own cost.
11. The transit insurance of the consignment will be arranged by the firm at his own cost from the date of loading and up to un-loading date in joint name of RVPN and transporters. The first name in the policy shall be SE (T&C) RVPN, Kota. The premium charges will be borne by the firm. The cost of the structure material to be transported will be intimated by the work incharge.
12. Service tax if applicable will be paid by the firm at his own cost at per prevailing rates.
13. Tenderer should be registered with SERVICE TAX DEPARTMENT (Registration under SERVICE TAX is required when the taxable value of services exceeds 10 lacs in a financial year).
14. The work of transportation of earthing material etc. will be completed within 7 days from the date of clearance given by the work incharge.
15. The detention charges will not be paid by the Deptt. as the loading and un-loading is to be done by the contractor.

16. If the work is not completed within completion period, penalty @ 0.5% per week or part thereof will be recovered from contractor's bills subject to maximum 10% of delayed quantity.
17. Proper work quality shall be ensured and checked by the field officers strictly as per specification of the 'G-Schedule' etc. and record a certificate to this effect in the MB.
18. 100% payment will be arranged through the Accounts Officer (T&C), RVPN, Kota after deducting all statutory deductions as per rules come into force from time to time.
19. The firm having Trailor and facility of loading and un-loading will be eligible for awarding the work.
20. All sorts of T&P required for the job will be arranged by the contractor at his own source and cost.
21. The successful bidder will have to deposit the SD equivalent to 2% of the order value within 15 days of receipt of order. In case of failure in depositing the said SD amount, it shall be treated as breach of contract and RVPN expenses shall be recovered from the contractor by forfeiting the EMD. The above SD will also be refunded after completion of work as per specifications.
22. Safe execution of work shall rest with the tenderer. Nigam shall not bear or share any compensation for 'Fatal' or 'Non-Fatal' accident. Care shall be taken to avoid any damages to Nigam's property in vicinity. Any such damages shall be sole responsibility of the contractor executing the work.
23. All the documents issued shall be submitted by the tenderer duly filled up in all respect with seal & signatures on each page.
24. The purchaser reserves the right to cancel any part or complete tender without assigning any reason.
25. In case of dispute arise between the purchaser and the contractor, the decision of the CE (T&C), RVPN, Jaipur will be final and binding on both the parties.
26. The successful contractor will execute the contract agreement on non-judicial stamp paper of Govt. of Rajasthan @0.25% of the contract value within 10 days of issue of work order.
