2. Tender received after scheduled time may not be accepted and if delivered after that time is liable to be rejected.
3. Tenders should addressed to **AEN, 132 KV GSS**, Rajasthan Rajya Vidyut Prasaran Nigam Limited, Bagdi(Dausa) and placed in a cover super scribed as "**Supply of water for Drinking as per Requirement per day's tanker capacity 4000 Ltrs Each and filling in GLR tank at 132 KV GSS, RVPN, Bagdi(Dausa)**" due on **27/03/2017**.
4. Tender should be put in a tender box kept in the office or may be sent by post preferably under registered cover.
5. Rates are to be quoted for delivery of material as per our specification.
6. Validity of Rates - The rates should remain valid for a period of 120 days from the date of opening of tender after which it will be at the option of tender.
7. The tender should be completed in all respect and incomplete tender are liable to be rejected.
8. Adherence to Specification - In giving rates the tendered shall specify complete specification and make and brand of the material/equipment offered for supply/work. The purchaser reserves the right the tenders in case a tender offers to supply material exactly as per our specification, he should specifically mention the same in his tender.
9. Bills - The bills are to be sent in triplicate addressed to the consignees which shall be intimated while placing order.
10. Payment of Bills - Bill after verification shall be sent to Account Officer (T&C), Bharatpur who will arrange payment through RTGS/NEFT within a month of

receipt of bill in the consignee's office provided the work complete is to the specification and in time.

11. The tender are to be written ink only the rates should be given both in words as well as in figures. All additions should be made clearly dated/initiated.

12. Supply of water will be completed up to 07:30 Hrs. daily w.e.f. 01.04.2017 to 31.03.2018. If water not supplied with in time period, the penalty shall be imposed twice the order rate.

13. Conditional tender will not be accepted/considered.


14. The quantity of water tanker supplied for the financial year 2017-18 but the supply can be stop before 30 days as and when the suitable arrangement of water supply start by own source of RVPN, for which no claim shall be raised by your side for remaining supply.

15. EMD @2% shall be deposit by the lowest firm within 7 days from the opening of the tender, otherwise the tender shall be deemed to be cancelled.

16. The undersigned reserves the right to reject any/all tenders in part or full without assigning any reason thereof.


17. All disputes shall be subject to jurisdiction of court in Rajasthan State only. In case of dispute the decision of SE (T&C), Bharatpur will be final and binding on both the parties.
