TERMS & CONDITIONS.

Terms & Conditions:-

1. Rates should be quoted inclusive of all type of taxes & charges but exclusive of Service Tax which will be paid as per rules.
2. The vehicle provider will have to submit his bills (monthly basis) for arranging payment. 100% Payment shall be made by the Accounts Officer (T&C-Rural), RVPN, Jaipur through RTGS against your monthly bills duly verified by this office.
3. The vehicle registered as Taxi not more than 05 years old and will be maintained clean, good and perfect condition by firm.
4. Copy of Registration certificate, Insurance, Fitness, Road Tax, Driver License, Pollution under control certificate and other relevant documents are to be submitted with the tender.
5. The driver license should be commercial.
6. Any compensation payable for damaged caused due to accident by your Vehicle/ Driver to any party/ property shall be borne by you.
7. P.F. of Vehicle driver will be deducted as per Govt. rule/Act.
8. The hired vehicle may be parked in the RVPN premises. However in this case the safety & security of the vehicle shall not be responsibility of the RVPN and it will be at the risk of the Firm/Person.
9. Security Deposit shall be deposited @ 2% within 7 days from the date of issuing the order.
10. All taxes except toll tax shall be borne by the firm. Reimbursement of all toll tax paid by the firm shall be made on production of receipt of payment of all toll tax.
11. The rates as mentioned are firm and All legal deduction (if applicable), such as income tax (TDS) shall be made as per law /rules applicable at the time of payment.
12. The hired vehicle can be used anywhere in the state.
13. The minimum average of vehicle should be 12 Km / Litre.
