

Salient Terms and conditions as per above GOR circular is as follows:-

1. Rate for hire shall be Rs. 26400/- for run upto 1500 km per month.
2. For Kms run more than 1500Km/Month the payment shall be done @ Rs.10.00 per Km as applicable according to above referred GOR letter.
3. The above rates are variable as per Govt of Rajasthan orders from time to time.
4. Petrol/diesel/lubricant is to be supplied by contractor.
5. Goods and Services tax and toll tax shall be borne by Nigam. All other Taxes/expenditure is to be borne by contractor.

The interested taxi provider may send their consent along with complete documents of vehicle through registered post or e mail within 10 days i.e by 10.03.2022.
