

4. The working hours for hired vehicle would be 24 hrs/day without any holiday.
5. Any compensation payable for damages caused due to accident by contract vehicle / driver to any party / property shall be borne by the contractor . The department will not be responsible for the same.
6. The hired vehicle may be parked in the premises of RRVPNL, if space is available le. However in this case, the safety & security of the vehicle shall not be responsibility of the RRVPNL and it will be at the risk of contractor.
