ORDER

Sub:- Relaxation under Para 8(3)(ii) of Rajasthan State Pensioners Medical Concession Scheme, 2014.

As per the order of Disaster Management Relief and Civil Defence Department, GOR, issued by Chief Secretary, Rajasthan, [order no. 3928-31 dated 25.03.2020], it has been directed that guidelines issued by Government of India vide order number 40-3/2020-DM-I(A) dated 24-03-2020 be strictly complied with. As per the order and detailed guidelines of Gol, there will be complete lock down for 21 days i.e. from 25-03-2020 to 14-04-2020. Home Department has also issued detailed guidelines vide order no. F33 (2) Home/Gr.9/2019 dated 26-03-2020.

In light of the above orders, in partial relaxation to the provisions of Para 8(3)(ii) of Rajasthan State Pensioners Medical Concession Scheme, 2014, Pensioners suffering from High Blood Pressure, Heart Disease, Diabetes, Kidney Failure, Renal Disease, Cancer, are allowed by giving relaxation to purchase medicines as per prescription from Authorised Medical Attendant in case of outdoor treatment from private licensed medical shops without NAC from CONFED and Upbhokta Sangh or Drug Distributions Centres.

This relaxation is given only for the Lock-down period. Medicines required till 31st May, 2020 may be purchased from private licensed medical shops on prescription from Authorised Medical Attendant.
