"If a person selected as above and appointed to a Post/cadre/service concerned against vacancies of a particular year for which a competitive exam was conducted in accordance with these regulation, does not join on the post offered to him/her or resigns or expires, in that event the said vacancy shall be treated as fresh vacancy."
