ORDER

Sub:- Amendment in Service Regulations for ensuring reservation to More Backward Classes (MBC), Economically Weaker Sections (EWS) and also about maximum age limit for Persons with disabilities.

Pursuant to the decision taken by the Co-ordination Committee in its 22nd meeting held on 08.11.2019, to ensure reservation to "Economically Weaker Sections" (EWS) & "More Backward Classes" (MBC), in appointments by direct recruitment on the lines of notifications dated 13.02.2019, 19.02.2019 and 20.10.2019 issued by the Department of Personnel, GoR, following amendments are hereby made in various service Regulations of RVPN, namely:-

- (1) In the existing regulation as mentioned in the column number 3 against each of the Service Regulations mentioned in column number 2 of the 'Table' given below, the existing expression "*Backward Classes, Special Backward Classes and Economically Backward Classes*" wherever appearing, shall be substituted by the new expression "*Backward Classes, More Backward Classes, Economically Backward Classes and Economically Weaker Sections*".
- (2) After the existing regulation mentioned in column number 3 against each of the Service Regulations mentioned in column number 2 of the 'Table' given below, following new provision may be inserted as a new regulation as mentioned in column number 4, namely :-

"Reservation of vacancies for Economically Weaker Sections:-

Reservation of vacancies for **Economically Weaker Sections** shall be 10% in direct recruitment in addition to the existing reservation. In the event of non-availability of eligible and suitable candidate amongst Economically Weaker Sections in a particular year, the vacancies so reserved for them shall be filled in accordance with the normal procedure.

Explanation: For the purpose of this rule '**Economically Weaker Sections**' shall be the persons who are bonafide resident of Rajasthan and not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes, the Backward Classes, the More Backward Classes and whose family has gross annual income below rupees 8.00 lakh. Family for this purpose will include the person who seeks benefit of

reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application."

(3) The existing proviso number (i) of the regulation mentioned in column number 5 against each of the Service Regulations mentioned in column number 2 of the 'Table' given below, shall be substituted by the following new provision, namely:-

- (i) the upper age limit mentioned above shall be relaxed by :
- 5 years in the case of male candidates belonging to the Scheduled Caste, Scheduled Tribe, Backward Class and More Backward Class;
 - 5 years in the case of woman candidates of Unreserved (General) Category, Economically Backward Classes and Economically Weaker Sections; and
 - 10 years in the case of woman candidates belonging to Scheduled Caste, Scheduled Tribe, Backward Class and More Backward Class.

(4) In the Schedule-II appended to each of the Service Regulations mentioned in column number 2 of the 'Table' given below, the existing entries appearing at para 6(i) & 6(ii) under serial numbers mentioned in column number 6 of the following Table, shall be substituted by the following, namely:-


- UR Category candidates - 30% marks
- SC/ST/BC/MBC/EWS/Ex-servicemen/
PWD (PH) category candidates - 20% marks
