
**Terms and conditions:-**

1. They shall be entitled to avail gazetted holidays and paid Causal Leave of 09 days in a year. No other kind of leave shall be admissible to them. For each day's absence without leave, 1/30<sup>th</sup> of monthly fixed consolidated remuneration will be deducted.
2. They shall mark daily attendance through biometric machine/register.
3. They shall be entitled for payment of only fixed consolidated remuneration after completion of the month as payable vide amendment GOR's Circular No.F.17(10)/DOP/A-II/94 dated 08.02.2018, as adopted by RVPN vide order No.250 dated 14.03.2018.
4. They shall not be entitled to get medical reimbursement as a regular employee.
5. They shall be allowed travelling allowance as per category prescribed in TA Rules, based on his monthly consolidated remuneration.
6. The Competent Authority may terminate their services by giving 15 days' notice, in case the services are not found satisfactory or on breach of any condition of re-appointment.
7. The above payment shall be charged against the code head G/L Account 4761051, amount to be paid to Ex-employee. \*



In case above terms & conditions are acceptable, the above mentioned retired officials shall report to their respective reporting officer for further assignment.
