Dear Sir,

With reference to above cited subject, for providing consultancy services for Rajasthan Electricity Regulatory Commission compliance and filing of Annual Revenue Requirement (ARR) for FY 2022-23 along-with Truing up for FY 2020-21, the work order amounting to Rs. 5,00,000/- (Plus applicable Tax) is here-by placed on the following terms & conditions:-

A) Scope of work /services :

- (i) Preparation / filing of ARR and Tariff petition for the year 2022-23 and Annual Performance Review (APR) for the year 2020-21 on the basis of Audited Annual Accounts.
- (ii) Segregation of Financial Statements in three business areas of RVPN (Transmission, SLDC and Partnership Projects) and filing segregated ARR for three business areas.
- (iii) Providing support in stakeholder consultant process including preparation of response to the Data Gaps of RERC, preparation of response to the queries/objection of public representative/ respondents and preparing of talking point for hearing and representation from RVPN side before RERC. Petition of Hindi version in required number of copies.
- (iv) Analysis and review of final tariff order issued / passed by RERC and review petition be filed, if any.
- (v) Providing additional information in respect to other states regulations, policy and order sought by RVPN from time to time as and when required and its comparison with RERC/RVPN.

B) Terms of payment

- (i) 40% of the consultancy fee on satisfactory completion of assignment mentioned at item No.(i) to (ii) of **Point A** for the period concerned.
- (ii) 30% of the **consultancy** fee on satisfactory completion of assignment mentioned at item No. (iii) of **Point A** for the period concerned.
- (iii) 30% of the **consultancy** fee on satisfactory completion of assignment mentioned at item No. (iv) of **Point A** for the period concerned.

C) Submission of petition/ reply

The consultant shall furnish the final draft petition /reply on referred matter to the SE (NPP&RA), RVPN Jaipur being a nodal officer for RERC matters.

D) Invoice / Bills

All the bills / invoices shall be submitted in triplicate and addressed to the Sr. Accounts Officer (B&R-W&M), RVPN, Jaipur. The payment shall be released by Sr. Accounts Officer (EA-Cash), RVPN, Jaipur on receipt of the bills/invoices verified by Sr. Accounts Officer (B&R-W&M), RVPN, Jaipur.

E) Contract Agreement

The contract agreement shall be executed on non-judicial stamp paper of @ 0.25% of the contract value with the SE (NPP&RA), RVPN being a nodal officer for RERC matters.”
