**Sub:- Relaxation under Para 8(3)(ii) of Rajasthan State Pensioners
Medical Concession Scheme, 2014.**

Vide Finance Department order of even number dated 30-3-2020, the relaxation was given under the provisions of Para 8(3)(ii) of Rajasthan State Pensioners Medical Concession Scheme, 2014 for the lockdown period i.e. upto 31-5-2020 to the pensioners to purchase medicines without NAC from CONFED and Upbhokta Sangh or Drug Distributions Centres from private licensed medical shops on prescription from Authorised Medical Attendant.

Looking to the present pandemic situation due to Covid-19 and various directions / guidelines issued by Government of Rajasthan to stop the outbreak of Coronavirus, and as per para 16(b) Rajasthan State Pensioners Medical Concession Scheme, 2021 that the provisions laid down under Rajasthan State Pensioners Medical Concession Scheme, 2014 shall be continued till RGHS card is issued, the relaxation under Para 8(3)(ii) of Rajasthan State Pensioners Medical Concession Scheme, 2014 is given till 31st July, 2021, for purchase medicines without NAC from CONFED and Upbhokta Sangh or Drug Distributions Centres from private licensed medical shops on prescription from Authorised Medical Attendant.


