Sub.:- Regarding relaxation to the pensioners to deposit PMCF renewal fee for the F.Y. 2020-21.

In light of the orders issued by the Govt. of India and State Govt. of Rajasthan regarding Lock Down due to COVID-19 up to 3rd May of 2020, partial relaxation under the provisions of 5 (iii) (b) (i) & (ii) of Rajasthan Rajya Vidyut Pensioners Medical Concession Fund Scheme-2000 is hereby given to the pensioners for deposition of PMCF renewal fee up to 31st July 2020 for the F.Y. 2020-21.
