Order

Sub: - Amendment in JVVNL Employees Service Regulation, 1964.

The Board of Directors, Jaipur Discom, in its 281st meeting held on dated 30.12.2019 has accorded its approval to adopt the provisions of 'Special Casual Leave' provided in Rajasthan Service Rules and inserting the same as Regulation 44 (3) above Regulation 45 in the JVVNL Employees Service Regulations, 1964, as follows, namely: -

"44 (3) Special Casual Leave may be allowed to a Nigam employee for a period not exceeding 30 days in any one calendar year. The period of absence in excess of 30 days shall be treated as regular leave of the kind admissible under the relevant leave rules applicable to the persons concerned. For this purpose, Nigam employee may, as a special case, be permitted to combine special casual leave with regular casual leave.

Under the above provision the special casual leave may be allowed when a Nigam employee participates in mountaineering expeditions approved by the Indian Mountaineering Foundation".
