Order

Sub: - Grant of Assured Career Progression under RCS(RP) Rules, 2008.

In exercise of powers conferred vide order No. JPD/CAO(IA)/AO/Rules/F.90/D.3203/ dated 20.01.2014, the Managing Director is pleased to adopt the Finance Department, GoR's Memorandum No. F.14(88) FD/Rules/2008-I dated 24.07.2017 and No. F.14(88) FD/Rules/2008-II dated 24.07.2017 alongwith amendment made vide Memorandum No. F.14(88) FD/Rules/2008-I dated 07.10.2020 and F.14(88) FD/Rules/2008-II dated 07.10.2020.

Accordingly, the following new proviso is inserted below existing proviso under para No.(iii) of sub para (7) of the Nigam's order No.1060 dated 26.05.2010 (JPD/Rules- 646) and para No.(iii) of sub para (8) of the Nigam's order No. 1059 dated 26.05.2010 (JPD/Rules-647), namely: -

“Provided further also that any Nigam employee who is remarried, which is not against any law and before such remarriage he/ she is not disqualified for grant of Assured Career Progression under this clause, he / she shall be entitled to Assured Career Progression, if any child is born out of single delivery from such remarriage.”

This order shall come into force (i) w.e.f. 01.09.2006 provided that no arrear of pay and allowances thereon shall accrue to a Nigam employee for the period from 01.09.2006 to 31.12.2006 as per provisions of rule 26 of Annexure -‘A’ appended with order No. JPD/ Sr.AO(HQ)/AAO(Rules)/F.176/D.1612 dated 01.10.2008 (JPD/Rules-499) and /or (ii) w.e.f. 01.01.2006 provided that no arrear of pay and allowances shall accrue to a Nigam employee for the period from 01.01.2006 to 30.06.2013 as per provisions of rule 27 of Annexure-‘A’ appended with order No. D. 1612 dated 01.10.2008 (JPD/Rules-499) amended vide order No. JPD/CAO(IA)/AO/Rules/F.176/D.1091 dated 01.07.2013 (JPD/Rules-917).
