Circular

After enactment of RTPP Act, 2012/ RTPP Rules, 2013 , procurement of goods , works and services is essentially to be made by the procuring entities in adherence to the provisions laid down under the said Act/Rules. It has however, been brought into the notice that provisions of the said Act/ rules are not being followed completely, while making procurement by the procuring entities of the Nigam, which is absolutely undesirable. In this regard, the A.G. has also taken a stern view during the course of audit of concerned offices of procuring entities. The management has taken a serious view for such an act of slackness in the matter.

All concerned officers / procuring entities are therefore, advised to ensure the strict compliance of the provisions of the RTPP Act, 2012/ RTPP Rules,2013 in procurement of goods , works and services. Non-compliance in the matter will attract disciplinary action against the defaulting officer.
