## ORDER

**Sub: - Incentive Scheme on Sale of Scrap by Auction.**

Pursuant to the decision of the Working Group constituted vide order No. 1411 dated 07.07.2017 for monitoring the implementation of Financial Break Even Plan(BEP), taken in its meeting held on 12.07.2017, following scheme is hereby introduced for providing cash incentive to various officers/ employees of the Nigam for identifying the scrap lying in the field and to get deposit the same into respective ACOS.

Cash incentive @ 5% of the amount realized from auction of scrap deposited shall be awarded which shall further be distributed among the concerned officers/employees in the following manner: -

For the above purpose Feeder Incharge of all the Sub-Divisions shall identify the scrap lying in the area of their respective feeder and intimate to the concerned JEN for further deposition of the same into the respective ACOS. The incentive Scheme shall be applicable for the scrap deposited from the date of issue of this order and shall be valid till 31<sup>st</sup> December, 2017 which shall be reviewed thereafter for further extension.

For payment of incentive, the Superintending Engineer (I&S), JPD, Jaipur shall issue the sanction with the concurrence of concerned Accounts Authority attached with him.

This order is issued subject to ratification by the Board of Directors.


