ORDER

Sub:- Delegation of Powers to take "No Appeal Decision" against orders passed by DJ Courts and below, Permanent Lok Adalat, DFCP, SCDRC etc.

The Nigam's order issued vide No. JPD/CAO(IA)/AO(Rules)/ F.60/D.2043 dated 25.07.2017 is hereby withdrawn with immediate effect. Henceforth, the powers prevailing under order No. JPD/CAO(IA)/AO(Rules)/ F.60/D.2987 dated 27.01.2016(JPD/Rules-1008) shall be exercised by the authorities of Discom with regard to take decision of "No Appeal Decision" against orders passed by the DJ Courts and below , Permanent Lok Adalat , DFCP, SCDRC etc. which are reiterated hereunder:-

S.No.	Financial implication	Powers vested with
1.	Upto Rs. 20000/-	Incharge Legal Cell
2.	More than Rs. 20000/- and upto Rs. 50000/-	CE(PPM)/HOD-Legal Cell
3.	More than Rs. 50000/- and upto Rs. 100000/-	Director (Technical)
4.	Above Rs. 100000/-	CMD/MD

Besides, if some policy decision or legal issue is involved , then concerned officer should put up the matter to MD/CMD for "No Appeal" decision even if it is lying under his pecuniary powers and higher authorities may also take decision even when powers are vested with the lower authorities.

The powers for filing Appeal upto DJ Courts & State Consumer Dispute Redressal Commission shall be vested with the respective Circle Superintending Engineers. The powers for filing appeal in Higher Courts , shall be vested with the concerned CMD/MD as usual as mentioned in letter No. RVPN/S.3()/D.14 Jaipur dated 02.08.2000 issued by the Addl. Secretary (Admn.)RRVFN, Jaipur.

This order shall be deemed to be effective from 29.03.2019 and this bears approval of the Managing Director, Jaipur Discom.


