Order

Sub: -Amendment in the JVVNL Compassionate Appointment of Dependants of Deceased Nigam Servants Regulations 2016.

The Board of Directors in its 271st meeting held on 28.01.2019 accorded its approval to adopt the Department of Personnel, GoR's Notification No. F.3(1) DOP / A-II / 2013 dt. 02.01.2017 by making necessary amendment in the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants Rules, 1996. Accordingly, following amendments are hereby made in the JVVNL Compassionate Appointment of Dependants of Deceased Nigam Servants Regulations 2016:

1. Existing Regulation 9 of the JVVNL Compassionate Appointment of Dependants of Deceased Nigam Servants Regulation 2016 shall be substituted by the following namely: -

“9- Procedural requirement etc -- The procedural requirement for selection such as:

- i. Computer qualification shall not be insisted upon at the time of appointment. The dependants of the deceased Government Servant shall have to possess any of the computer qualification as prescribed in the relevant rules within the period of probation, failing which his / her probation shall be deemed to be extended, unless the appointing authority terminates his / her services finding the performance wholly unsatisfactory.
- ii. Training or departmental examination or typing on computer shall not be insisted upon at the time of appointment. The dependants shall however, be required to clear such training or departmental examination or typing test on computer in any one language, either in English or in Hindi, within a period of three years, unless the period is relaxed by the Chairman & Managing Director, JVVNL for entitlement for confirmation, failing which his / her appointment shall be liable to be terminated. No annual grade increments will be allowed until he / she acquires such qualification. On acquiring such qualification, annual grade increments shall be allowed notionally from the date of appointment but no arrears shall be paid.

Provided that the widow appointed under the provisions of these regulations shall be exempted from having computer qualification and passing the typing test on computer.

Provided further that the persons with disabilities appointed under the provisions of these regulations shall be exempted from passing the typing test on computer.

Provided that no candidate who has more than two children on or after 01.06.2002 shall be eligible for appointment to the service. But the candidates having more than two children shall not be deemed to be disqualified for appointment so long as the number of children he / she has on 01.06.2002 does not increase. Where a candidate has only one child from the earlier delivery but more than one child are born out of a single subsequent delivery, the children so born shall be deemed to be one entity while counting the total number of children. However, these provisions shall not be applicable while appointing widows.


2. Existing Regulation 7 (4) of the JVVNL Compassionate Appointment of Dependents of Deceased Nigam Servants Regulation 2016 shall stand omitted.

For the purpose of this regulation, the typing test on computer shall be conducted as per circular No. F.3 (1) / karmic / Ka-2 / 2013 dated 21.06.2017 (copy enclosed) or orders issued from time to time in this regard by the Nigam.

It shall come into force with immediate effect.

राजस्थान मृत सरकारी कर्मचारियों के आश्रितों को अनुकम्पात्मक नियुक्ति नियम, 1996 के नियम-9 के अन्तर्गत प्रक्रियात्मक अपेक्षा में तीन वर्ष के भीतर स्थायीकरण के लिए पात्र बनाने हेतु विहित प्रशिक्षण/विभागीय परीक्षा/कम्प्यूटर पर टंकण परीक्षा (अंग्रेजी/हिन्दी) उत्तीर्ण करना अनिवार्य है। भाषा विभाग के परिपत्र दिनांक 03.07.2015 एवं कार्मिक विभाग के परिपत्र दिनांक 26.08.15 के द्वारा टंकण परीक्षा का आयोजन भाषा विभाग द्वारा केवल जयपुर में निम्नानुसार किया जा रहा है:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants Rules, 1996, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants (Amendment) Rules, 2017.

(2) They shall come into force with immediate effect.

2. **Substitution of rule 9.**- The existing rule 9 of the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants Rules, 1996, shall be substituted by the following, namely.-

"9. Procedural requirement etc.- The procedural requirement for selection such as,-


- (i) computer qualification shall not be insisted upon at the time of appointment. The dependants of the deceased Government Servant shall have to possess any of the computer qualification as prescribed in the relevant rules within the period of probation, failing which his/her probation shall be deemed to be extended, unless the appointing authority terminates his/her services finding the performance wholly unsatisfactory;
- (ii) training or departmental examination or typing on computer shall not be insisted upon at the time of appointment. The dependants shall however, be required to clear such training or departmental examination or typing test on computer in any one language, either in English or in Hindi, within a period of three years, unless the period is relaxed by Department of Personnel, for entitlement for confirmation, failing which his/her appointment shall be liable to be terminated. No annual grade increments will be allowed until he/she acquires such qualification. On acquiring such qualification, annual grade increments shall be allowed notionally from the date of appointment but no arrears shall be paid:

Provided that the widow appointed under the provisions of these rules shall be exempted from having computer qualification and passing the typing test on computer.

Provided further that the persons with disabilities appointed under the provisions of these rules shall be exempted from passing the typing test on computer.

Note: For the purpose of this rule the Director, Bhasha Vibhag shall conduct typing test on computer every year irrespective of the number of candidates."
