ORDER

Sub:- Scheme for grant of Medical Concession to the pensioners of the company.

The Chairman & Managing Director, RVPN in consultation with the Director(F&CA), has decided to make the following amendment in the Pensioners Medical Concession Scheme, 1992, namely:-

In the said Scheme, the existing sub para(a) & (b) of para 4 shall be substituted by the following:-

4. RATE OF SUBSCRIPTION TO THE FUND:-

(a) With a view to provide medical concession to the pensioners of the companies who are treated as out-door & in-door patients in a Govt. Hospital/ Clinic, Dispensary etc. RRVPMCF, has been constituted into which subscription shall be paid by the serving employees of the company at the following rates:-

| i) | Employees drawing pay upto Rs. 3000/- | Rs. 25.00 p.m. |
| ii) | Employees drawing pay above Rs. 3000/- but upto Rs. 6000/- | Rs. 35.00 p.m. |
| iii) | Employees drawing pay above Rs. 6000/- but upto 9000/- | Rs. 60.00 p.m. |
| iv) | Employees drawing pay above Rs. 9000/- | Rs. 100.00 p.m. |

(b) (i) All existing companies employees whether temporary or permanent and erstwhile Board's employees appointed on or after 1.1.98 shall pay subscription at the rates mentioned in para 4 (a) above from the pay bill for the month of April, 2002, payable in May, 2002.

(ii) In the case of those employees who opt to retain the existing scale of pay, the term 'pay' will include, in addition to pay in the pre-revised scale, dearness allowance and interim relief appropriate to that pay admissible under orders in existing on 1.1.1996.

This order shall be applicable w.e.f. 1.4.2002.
