ORDER**Sub: Amendment in the RSEB - Payment of Gratuity Rules, 1972.**

The Board of Directors in its 39th meeting held on 25th April, 2003 has decided to make following amendment in the RSEB- Payment of Gratuity Rules, 1972 namely,

In the said Rules,

Following new Sub-rule-4 shall be inserted under Rule 3-

- 4 (a) Where departmental proceedings have been instituted under Regulation-6 of the RSEB Classification, Control & Appeal Regulations, 1962 for imposing any of the penalties specified in clauses (a) to (d) of Regulation-5(1) of the said Regulations a provisional gratuity not exceeding 95% of the maximum gratuity which would have been admissible on the basis of qualifying service up to the date of retirement of the employee, or if he was under suspension on the date of retirement up to the date immediately preceding the date on which he was placed under suspension, shall be authorized to be paid to the employee.
- (b) Payment of provisional gratuity made under proviso to Regulation 4(a) above shall be adjusted against the payment of final gratuity sanctioned to such employee upon conclusion of such proceedings.
