**ORDER**

Sub:- Rate of interest to be allowed to the members of R.R.V.K.  
General Provident Fund.

Consequent upon declaration of interest @ 9% (Nine percent) per annum to be allowed on the accumulations at the credit of subscribers under General Provident Fund during the year beginning Ist April, 2002 by the Government of Rajasthan (Finance Department) vide Circular No.F.2(1)TD/Rates/96 dated 9.9.2002 and thereafter @ 8% (Eight percent) per annum w.e.f. Ist April, 2003 as per Government of Rajasthan Circular No.F.14(19) FWM/73 dated 6.6.2003, the Chairman & Managing Director, RVPN in consultation with Director(F&CA), RVPN has decided to revise the rate of interest as above in place of 9.5% in respect of the members of RRVK General Provident Fund.

It has further been decided that recovery of 0.5% w.e.f. 01.04.2002 and @ 1% w.e.f. 01.04.2003 interest excess paid, if any, to the employees who retired during this period shall be made from their pension. The interest allowed to the existing employees on the balance of G.P.F. will also be revised accordingly.


