

**ORDER**

In the meeting of Co-ordination Committee held on 02.06.2003, it has been decided that the amendment made vide Notification No. F.5 (51)DOP/A-II/88 dated 11.09.2002 by the State Government in Rule 10 of the Rajasthan Compassionate Appointment of Dependents of Deceased Govt. Servant Rules, 1996 may be adopted by all the five Electricity Companies and the functions of Department of personnel in State Government by exercised by the Board of Directors of the Companies. NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of the Rajasthan hereby makes the following rules further to amend the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants Rules, 1996, namely:-

1. Short title and commencement :- (1) These rules may be called the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants (Amendment) Rules, 2002.  
(2) They shall come into force with immediate effect.
2. Amendment of rule 10 :- The existing sub-rule (3) of rule 10 of the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants Rules, 1996, shall be substituted by the following, namely:-  
"(3) Such application shall be made to the Head of the office/Department in the proforma attached as Annexure-A to these rules, within a period of 90 days from the date of death of the Government servant. The applicant shall submit an affidavit in support of monthly income (from all sources) of all the family members mentioned in Column No. 7 of part-I of the application.

Provided that in an exceptional case where the State Government in the Department of Personnel is satisfied that the operation of provisions of this sub-rule causes financial hardship to the family of the deceased Government servant and considers it necessary or expedient to relax the provisions of this sub-rule in a particular case, it may relax the provisions of this sub-rule to such extent and subject to such conditions as it may consider necessary for dealing with the case in a just and equitable manner."
