CIRCULAR

Subj:- Opportunity for change of office for presenting medical claims by the pensioners.

As per provisions contained under para 10(iii) of the Pensioners Medical Concession Scheme, 1991, the claims for reimbursement of medical expenses are to be presented in the office from which the pensioner is getting his pension or in the office where he has been registered under the scheme for such payments.

Some of the pensioners represented that they may be given an opportunity to change the office for presenting the medical claims for reimbursement. The issue was discussed in the 3rd meeting of PMCF Trust (common for all the successor entities of erstwhile RSEB) held on 29.3.2003. It has been decided to allow change of office for submission of medical reimbursement. The change will, however, be allowed only once. For this purpose, the pensioner will make a written request to the pension payment authority or to the authority with whom he is registered under the PMCF, as the case may be, who, in turn, will forward the same to the office from where future payments are proposed to be arranged.
