ORDER

Sub:-Scheme for grant of Medical Concession to the pensioners of Power Sector Companies.

The Chairman & Managing Director, RVPNL in exercise of authority given by the Board of Directors, vide No. RRVPN/CAO/P&F/PMCF/D.3957 dt.6.8.2001, has been pleased to make the following amendments in the Pensioners Medical Concession Scheme, 1972 namely:-

1. The figure Rs.56,000/- appearing in Para 3(D)(a) and (b) shall be substituted by the figures Rs.44,000/-
2. The following shall be inserted as new Para 3(F) after the existing Para 3(E).

"3(F)- Treatment of diseases other than Heart ailment in recognised hospital outside the State."

"For the treatment of diseases other than heart ailment in recognised hospital outside the State, financial assistance shall be limited to the expenditure likely in general ward of AIMS, New Delhi. In absence of certificate from the AIMS, New Delhi pensioner may be allowed 80% of the cost of medicines and 60% of expenditure incurred on tests."

3. Existing Para 3(ii)(i) shall be substituted by the following:-

"Cost of hearing aid:- The pensioner will submit their claims to the concerned office, reimbursement of which will be made to the extent of actual cost or Rs.5,000/- whichever is less"

These amendments shall come into force w.e.f. 13.4.2004.
