CIRCULARSub :- Valuation of Stamp duty on execution of contract agreement(s).

The matter with regard to valuation of Stamp duty, in view of amendment made in rule NO. 29(F) of the Indian Stamp Duty Act [read with item 66 of the IIInd schedule of the Rajasthan Stamp Law (adaption) Act-1952] has been under consideration for some time. It has also been examined by Shri Manish Bhandari, Nigam's advocate and opined that valuation of Stamp duty on execution of contract agreement in respect of all the matters e.g. purchase of material, works, repairs and maintenance etc., stamp duty is to be made as per above amendment w.e.f. 30.3.2000 the date of enforcement of the said amendment(s).


It is, therefore, enjoined upon all the concerned officers to ensure that henceforth while executing the contract agreements, levy of stamp duty as per scale(s) given below is made :-

<u>Contract Amount</u>	<u>Stamp Duty (Rs.)</u>
1. Amount not exceeding Rs. 10 lacs	100.00
2. Exceeding Rs. 10 lacs but upto Rs. 50 lacs	500.00
3. Exceeding Rs. 50 lacs	1,000.00

In case of contract agreement executed on or after 30.3.2000 but before coming into force of this order, such documents should also be revalued accordingly.

Above instructions should be complied with strictly.
