## ORDER

Sub :- Reimbursement of expenses for treatment taken in private Hospitals.

Pursuant to the decision taken in 43<sup>rd</sup> Coordination Committee's meeting held on 11.7.2002 and approval of the Board of Directors, JPD in its 24<sup>th</sup> meeting held on 27.7.2002, an order No. JPD/FA&COA/Rules/E.12/D. 2834 dt. 17.08.2002 was issued for reimbursement of expenses for treatment taken in a Hospital/Institution (other than a Govt. Hospital) within/outside the State.

In view of the decision taken by the Coordination Committee in its 70<sup>th</sup> meeting held on 29.05.2004, it has been decided to adopt following procedure for reimbursement of expenses for treatment taken in various authorized private Hospitals :-

(i) Re-imburement for tests/investigations may be allowed on the scale of rates for similar tests as prescribed by the Government of Rajasthan/Rajasthan Medicare Relief Society.

(ii) Ward/Accommodation Charges :

In case of indoor patient, Ward/Accommodation charges may be allowed as per Rajasthan Civil Services (Medical Attendance) Rules.

(iii) Cost of medicines & other equipments :

Cost of medicines in respect of reimbursable medicines may be allowed as per Rajasthan Civil Services (Medical Attendance) Rules. Requirement of NAC may be dispensed with. Cost of other equipments may be allowed as per orders issued by erstwhile RSEB/Nigam from time to time.

This would also apply to pensioners of the Nigam for reimbursement of treatment taken in a hospital/institution (other than a Govt. hospital) within/outside the State in continuation to order No. RRVPN/AS/GAD/F&R/E.34/D. 1339 dt. 11-12-2002, endorsed vide No. JPD/FA&COA/Rules/E.13/D. 5100 dt. 16-12-2002.

This is subject to ratification by the Board of Directors.
