**ORDER**


Sub :- Preferential Appointment to the Dependants of Deceased employee(s).

The Board of Directors in its 64<sup>th</sup> meeting held on 19.7.2004 has decided to make following additional provisions in addition to Rule 10(3) of the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants Rules, 1996, modified on 11.09.2002, for the cases of compassionate appointment wherein either widow has expired or reluctant to take the appointment and the eldest son/unmarried daughter is minor-

1. In the cases wherein widow is alive and the eldest son/unmarried daughter has not attained the age of 18 years, an intimation to this effect may be given by the widow to the Nigam within 90 days from the date of death. The format application for appointment of dependant may be submitted after attaining age of 18 years by the eldest dependant.
2. In the cases wherein spouse has also passed away before or within 90 days from the date of death of employee and the eldest son/unmarried daughter has not attained the age of 18 years, the said eldest dependant may submit his/her application within 90 days after attaining the age of 18 years.
3. The cases already returned by the Company on the ground of minority, may also be covered under the above provision.

The earlier order issued vide No. JPD/CAO/Rules/F.17/D. 866 dated 13.7.2004 is hereby withdrawn.
