

Sub: Allowing irregular subsidy on HBA taken by the employees from the approved Banks / Financial Institutions like HDFC, SBBJ, SBI, Canfin, violating instruction issued by order No.RVPN/AS/GAD/F&R/F.HBA/D368 dated 02.04.2004(F&R-49)&RVPN/AS/GAD/ F&R/ F. /D.542 dated 24.05.2002 (F&R-58).

It has been brought into my notice that in some of the circles, subsidy on HBA taken by the employees from the approved Banks / Financial Institutions like HDFC, SBBJ, SBI and Canfin is still being allowed, perhaps due to no clear instructions in the matter except the order No. RVPN/AS/GAD/F&R/F.HBA/D368 dated 02.04.2004 (F&R-49).The detailed instructions are already there, issued vide order No. RVPN/AS/GAD/F&R/F. /D.542 dated 24.05.2002 (F&R-58) stating therein to dispense with the subsidy of interest on HBA obtained from any of the above named financial institutions / Banks.

It is apprehended that despite clear mention in order (F&R-49) for not allowing any subsidy of interest due to reduction in the rate of interest by the Banks / Financial

Institutions, much lower than the rate of interest prescribed in the erstwhile RSEB Regulations for grant of HBA, after 01.04.2002 and dispensing with the facility of subsidy vide order (F&R-58) some circle might be allowing the subsidy, which is quite irregular on the one hand and a loss to the Nigam.

You are, therefore, instructed to stop forth with the subsidy of interest on HBA and to effect recovery of subsidy from the employee(s) concerned, if allowed after 31.03.2002 even on the cases sanctioned earlier, under intimation to this office.
