ORDER

Sub: - Scheme for grant of Medical Concession to the Pensioners of Power Sector Companies.

The Chairman & Managing Director, RVPN, in exercise of powers conferred vide order No. RVPN/CAO/P&F/PMCF/D. 3957 dated 06-08-2001, has been pleased to make the following amendments in the Pensioners Medical Concession Scheme, 1992, namely: -

- I the existing words "Implantation of Pacemaker and Angioplasty/Balloonplasty" appearing in sub-para 3B (i) shall be deleted and the existing Sub para 3B (ii) may be renumbered as Sub para 3B (iii) and new sub para 3B (i) may be inserted as under:-

A Pensioner and the members of his family as defined in sub-para (5) of para (2) of the scheme shall be entitled for grant of financial assistance in respect of specialized treatment of Implantation of Pacemaker and Angioplasty/Balloonplasty taken in Government Hospital within the State of Rajasthan as under:-

(a) **Pacemaker**

Actual cost of Pacemaker subject to the maximum of Rs.60,000/-

(b) Angioplasty/Balloonplasty

Actual expenditure incurred subject to the maximum of Rs.35,000/-

(c) For Stent/Stents

Actual expenditure incurred subject to the maximum of Rs.75,000/-

ii the existing para 3(D) shall be substituted by the following:-

"3(D) Treatment of heart ailment in recognized hospital outside the State (with or without the recommendation of the Medical Board)(w.e.f. 5.8.2004).

3(D)(a) In case it is recommended by the Medical Board that by-pass surgery for heart is indicated, the pensioner can get himself operated in any of the hospitals recognized by the Government outside the State for this purpose. Such pensioner may be allowed 80% of hospital expenses limited to Rs.48,000/- being 80% of General Ward charges of All India Institute of Medical Sciences, New Delhi.

3(D)(b) In case a pensioner undergoes by-pass surgery of heart (Cardio thoracic surgery) in any recognized hospital outside the State in emergent circumstances without any recommendation of the Medical Board, he may be allowed 80% of hospital expenses limited to Rs.48,000/- i.e. 80% of General Ward charges of AIIMS, New Delhi provided that he submits a Certificate from a Cardiologist who holds a degree of D.M. in Cardiology or MCh in Cardio Thoracic Surgery stating that pensioner's condition was such that immediate treatment was essential.

the following shall be inserted as new para :-

3(D)(c) In case a pensioner takes treatment of Angioplasty/ Balloonplasty and stent(s) in recognized hospitals outside the state, he/ she may be allowed financial assistance as under:-

(i) **For Angioplasty/Balloonplasty**

Actual amount of expenditure incurred subject to the maximum of Rs.35,000/-

(ii) **For Stent/Stents**

Actual cost of Stent / Stents subject to the maximum of Rs.60, 000/- (80% of Rs.75, 000/-).

III the existing para 4 shall be substituted by the following, namely: -

4- Rate of subscription to the Fund:-

With a view to providing free supply of medicines to the State Pensioners who are treated as outdoor and indoor patients at a Government Hospital / Clinic / Dispensary / Sanatorium etc. the " Rajasthan Pensioners Medical Fund" has been constituted into which subscription shall be paid by the serving Government servants at the following rates:-

S.No.	Category of Government Servants	Subscription per month
1.	Employee drawing pay upto Rs.3,000	Rs.35
2.	Employee drawing pay above Rs.3,000 but upto Rs.6,000	Rs.50
3.	Employee drawing pay above Rs.6,000 but upto Rs.9,000	Rs.80
4.	Employee drawing pay above Rs.9000	Rs.125

IV the existing sub-para (iv) of para 10 shall be substituted by the following, namely: -

(i) It will be obligatory for every pensioner drawing pension with in the State to get the medical card (Form No. PMCF-2)

renewed every year on payment of annual renewal fee and those who are drawing pension outside State shall be required to make one time payment for whole life as fee on the following scales:-

S.No.	Category of Pensioner	Amount in rupees	
		Annual renewal fee for those who are getting pension with in the State.	One time fee for whole life for those who are drawing pension outside the State .
1.	Pensioner who were in receipt of pay in scale No. 1 to 6 at the time of retirement	Rs.250	Rs.2000
2.	Pensioners who were in receipt of Pay in Scale No.7 & above at the time of retirement.	Rs.500	Rs.4000

"Provided that those pensioners who have already deposited one time payment for whole life PMCF Card need not be required to deposit annual renewal fee."

These amendments shall come into force w.e.f 01-01-2005 i.e. salary payable on 01-02-2005 as made effective by the Government of Rajasthan.
