2. The Manager, Temple of Ekadish Rudraji in Uttarkashi (Uttarakhand) shall be granted Compensatory Allowance at the rate of Rs . 480/- per month.
3. The grant of Compensatory Allowance during leave, temporary transfer, joining time etc. may be regulated accordingly to rules regulating grant of Compensatory (City) Allowance.

This order shall come into force with effect from 01.10.2017.
