ORDER

Sub: - Amendment in the Travelling Allowance Rules.

In light of the recommendations of the Coordination Committee in its 8th meeting held on 7th November, 2017 and approval of the State Government conveyed by the Energy Department, GoR vide its letter no. F4(43)Energy/2017 dated 01.01.2018 [Finance (Rules) Department ID No. 211700442 dated 01.01.2018], the Managing Director in consultation with the Director (Finance) is pleased to adopt, mutatis mutandis, the Govt. of Rajasthan's order No.F.6(7)FD(Rules)2017 dated 30.10.2017 amending the Rajasthan Travelling Allowance Rules and to amend the JVVNL Travelling Allowance Rules, 1971.

Accordingly, following amendments in JVVNL Travelling Rules, 1971 shall be made, namely: -

- (1) The existing Rule 2 (A) shall be substituted by the following, namely: -

Employees based on Basic Pay which includes pay in the level in the Pay Matrix shall be categorized in the following five categories: -

Categories	Class of Nigam's employees based on "Basic Pay" i.e. the pay drawn in the Pay Matrix of the prescribed Levels
Category 'A'	Employees drawing basic pay of Rs.95,000/- per month or above.
Category 'B'	Employees drawing basic pay of Rs. 49,000/- and above but below Rs. 95,000/- per month.
Category 'C'	Employees drawing basic pay of Rs. 39,000/- and above but below Rs. 49,000/- per month.
Category 'D'	Employees drawing basic pay of Rs. 26,000/- and above but below Rs. 39,000/- per month.
Category 'E'	Employees drawing basic pay below Rs. 26,000/- per month.

- (2) In Col. No. 1 of **Appendix – ‘A’ (Part-III)** – “Mileage Allowance for Travel by Air” – the existing words and figures “Rs. 27,000”, “Rs. 37,000” and “Rs. 80,000” wherever occurring shall be substituted by the words and figures “Rs. 69,000”, “Rs. 95,000” and “Rs.2,25,000”, respectively.

This order shall come into force with effect from 1.10.2017.

This is subject to ratification by the Board of Directors.
