ORDER

Sub: Amendment in the RVPN Pensioners Medical Concession Scheme.

In light of the recommendations of the Coordination Committee in its 8th meeting held on 7th November, 2017 and approval of the State Government, conveyed by the Energy Department, GoR vide its letter No. F.4(43)Energy/2017 dated 01.01.2018 [Finance (Rules) Department ID No.211700442 dated 1.1.2018], the Chairman & Managing Director, RVPN, in consultation with the Director (Finance) is pleased to adopt the Government of Rajasthan's order No. F.1(5)FD (Rules) /2017 dated 30.10.2017 in the matter of Scheme for grant of Medical Concession to Nigam's Pensioners.

Accordingly, the para-4 of the Rajasthan Rajya Vidyut Pensioners Medical Concession Scheme, 1991 shall be substituted by the following:-

"4. Rate of Subscription to the Fund.

- (a) With a view to providing Medical Concessions to the RRV Pensioners who are treated as outdoor and indoor patients in a Government Hospital/ Clinic/ Dispensary, etc., Rajasthan Rajya Vidyut Pensioners' Medical Concession Fund has been constituted into which subscription shall be paid by the serving employees of the Nigam at the following rates:-

| S. No. | Category of Nigam's employees (Basic Pay i.e. Pay in prescribed Levels in the Pay Matrix) | Subscription per month |
|--------|---|------------------------|
| i) | Employees drawing basic pay in the Pay Matrix upto Rs.18,000/- | Rs.205/- |
| ii) | Employees drawing basic pay in the Pay Matrix above Rs.18,000/- but upto Rs. 33,500/- | Rs.341/- |
| iii) | Employees drawing basic pay in the Pay Matrix above Rs.33,500/- but upto Rs. 54,000/- | Rs.511/- |
| iv) | Employees drawing basic pay in the Pay Matrix above Rs.54,000/- | Rs.680/- |

This order shall come into force with effect from 01.10.2017.

The Governor is pleased to make the following amendments in the Rajasthan State Pensioner's Medical Concession Scheme, namely -


In the said Scheme - the 'Rate of Subscription to the Fund' in the existing para 5 shall be substituted by the following, namely -

| 3. | Employees drawing basic pay in the Pay Matrix above Rs. 33500/- but upto 54000/- | Rs. 511.00 |
| 4. | Employees drawing basic pay in the Pay Matrix above Rs. 54000/- | Rs. 680.00 |
