In partial modification of this office order No.JPD/CAO/Rules/F.17/D.3851 dated 22.03.2006 (JPD/Rules-248) issued pursuant to decision taken in the 91st meeting of Co-ordination Committee held on 18th & 20th February, 2006, item No.(1) appearing in said order dated 22.03.2006 be read as under:-

“ In the cases wherein widow of deceased employee is alive and eligible for preferential appointment but reluctant in taking appointment, she shall be allowed to nominate any one of her sons/ unmarried daughters for preferential appointment. In case the nomination is of a minor, intimation to this effect would have to be given by the widow to the Nigam within 90 days from the date of death of the employee. The formal application for appointment may be submitted after attaining age of 18 years by the dependent.”
