ORDER

In view of Rajasthan Investment Promotion Scheme, 2010 issued vide notification No. F.12(28)FD/Tax /2001-63 dated 23/8/2010 which shall remain effective up to 31-03-2018, provision for 50% exemption in electricity duty is made under the clause (5) to various prescribed industries to whom entitlement certificate as prescribed under the scheme is issued for the period as mentioned in the order (seven years from the date of issuance of entitlement certificate) and Finance department, Govt. of Rajasthan vide Notification No. F.12(28) FD/Tax Div./2010-64 dated 25-08-2010. has allowed to reduce Electricity Duty by 50% payable on the energy consumed by such industries. For granting exemption the consumer has to produce the exemption certificate/order of the competent authority of the State Government to the unit offices of the JVVNL. The same has been approved by the Coordination committee in its 148th meeting held on 16/05/2011 for compliance by the Discoms of Rajasthan.

Hence, to implement the above decision for energy billing existing letter code "R" may be used at the 5th place of six digit tariff code. The unit officer shall send the revised tariff code in input form "2A" and for new consumers in "MF1A" to enable the computer agencies to bill such consumers on the reduced rate of Electricity duty. After completion of the exemption period the tariff code deleting letter code "R" is to be intimated by the unit officers to the billing agencies.
