NOTIFICATION

In exercise of the powers conferred by section 14 and 58 of the Rajasthan Power Sector Reforms Act, 1999 read with section 131 of the Electricity Act, 2003(Central Act No. 36 of 2003) and all other powers enabling it in this behalf, the State Government hereby makes the following scheme further to amend the Rajasthan Power Sector Reforms Transfer Scheme, 2000, namely :-

- 1. Short title and commencement.- (1) This Scheme may be called the Rajasthan Power Sector Reforms Transfer (Amendment) Scheme, 2019.
- (2) It shall come into force from the date of its publication in the official Gazette.
- 2. Amendment of rule 2.- In sub-rule (1) of rule 2 of the Rajasthan Power Sector Reforms Transfer Scheme, 2000, hereinafter referred to as the "said scheme", after the existing clause (k), following new clause (kk) shall be added:-
 - "(kk) " RUVNL" means the Rajasthan Urja Vikas Nigam Limited established by the State Government with the principal object of engaging in the business of purchase, procure, distribute, sell, trade, import, export, supply or accumulate or deal in bulk, in all forms of electrical power as power requirement of distribution companies."
 - 3. Amendment of rule 5.- In rule 5 of the said scheme,
 - after the existing sub-rule (3) and before sub-rule (4), following new sub-rule (3A) shall be inserted, namely:-
 - "(3A) Notwithstanding anything contained in this Scheme, the Assets and liabilities forming part of Distribution Companies as set out in Schedule EE shall stand transferred to and vest in Rajasthan Urja Vikas Nigam Limited en and from the effective date of transfer. The effective date for the purpose of this sub-rule(3A) shall be the 18.07.2019."
 - after the existing sub-rule (5), following new sub-rule (5A) (ii) shall be added, namely:-
- ગ્રાહ્મ કહિલા हारियात (5A)As a consideration for transfer and vesting of the Assets and Liabilities to RUVNL, as specified in Schedule EE,

the Distribution Companies may be issued shares and/or instruments if any, as the case may be after mutual negotiations."

(4) Addition of new Schedule.- After the existing Schedule-E and before the existing Schedule -F, following new Schedule-EE shall be inserted, namely:-

"SCHEDULE -EE

All the Power Purchase and Transmission Service Agreements entered into by the Distribution Licensees shall stand transferred and vested in Rajasthan Urja Vikas Nigam Limited."
