1. EMD could be furnished in **Banker's Cheque / D.D.** OR 20% in Banker's Cheque / D.D. and balance 80% in the form of Bank Guarantee.
 2. Furnishing of Earnest Money (Bid Guarantee) as per clause no. 7.0 of "Instruction to Bidders" (ITB) of the specification is essential. The bidders having vendor registration with Jaipur Discom under class E-I may furnish earnest money 1 % as against normal 2% of the estimated cost which may also be deposited as 20% in Banker's Cheque / D.D. and balance 80% in the form of Bank Guarantee.

The cost of tender specification (non-refundable) and EMD as above shall be payable in demand draft / Banker's Cheque in favour of the Accounts Officer (JPDC), Jaipur Discom, Jaipur can be deposited in the office of Accounts Officer JPDC, Jaipur Discom, Jaipur upto 2.00 PM one working day prior to the schedule date of opening of respective bids and tender processing fees of Rs. 1000/- (non-refundable) shall be payable in favour of the Managing Director, RISL payable at Jaipur.
