ORDER

Sub: Directions in the cases of Unauthorized use of electricity.

The activities covered under Section-126 of the Electricity Act-2003 where the electricity consumption is recorded correctly by the meter or can be correctly assessed from the meter reading are considered unauthorized use of electricity. In such cases on checking the premises, the Assessing Officer/Authorized Officer prima facie finds an evidence of any activity as per aforesaid explanation.

In the following cases of unauthorized use of electricity;

- i. use of electricity supplied under lower tariff for a purpose for which a higher tariff in force, or
- ii. exceeding the sanctioned connected load through meter, other than domestic and small (upto 5 kw load) non domestic consumers, or
- iii. for the purpose other than for which the usage of electricity was authorized; or for the premises or areas other than those for the electricity supply was authorized.
- iv. use of apparatus for splitting the phase to run a 3-phase appliance when 3-phase supply is not available to him, or
- v. non-compliance of orders imposing restriction on use of electricity during power cut/load shedding.

The Assessing Officer/Authorized Officer shall ask the consumer to remove the case of such unauthorized use of electricity immediately, failing which the Nigam shall serve a 24 hour notice asking the consumer to remove the cause of such unauthorized use of electricity, failing which his supply shall be disconnected.

The supply so constant shall be reconnected only after the receipt of a written intimation from the consumer about discontinuance of unauthorized use of electricity, to the satisfaction of the Nigam.

It has been observed that field officers are not serving any notice to the consumer to remove the unauthorized use of electricity and the consumer continues such unauthorized use of electricity considering that after deposition of assessed amount towards unauthorized use of electricity, the matter is over.

In such cases, when the consumer gets the electricity bill along with mis-use charges, dispute arises due to unawareness of the consumer regarding continuation of unauthorized use of electricity.

Therefore, to avoid such situation, all the field officers are directed that if the consumer not removes the cause of such unauthorized use of electricity immediately, a 24 hour notice asking the consumer to remove the cause of such unauthorized use of electricity invariably be served and failing which his supply shall be disconnected.

In the case of use of electricity through a tampered meter e.g. seal broken, glass broken etc., with no other evidence of dishonestly obstructing the electricity without noticeable fall in the recorded consumption, tampered meter shall be immediately rectified or replaced.

In the cases of restoration of the service through meter, disconnected by the Nigam, supply shall be immediately disconnected without any notice.

All concerned are directed to make strict compliance of above directions.
