QUALIFYING REQUIREMENT

1.0 NIT No.66 (17-18) (Proc.)

- 1.1 The bidders should have experience of similar nature of supply in any power station/any other Govt./ Public Sector/Reputed Industries and shall have to furnish copies of at least one or two PO executed during last five years in support of experience. The bidders should ensure supply material of standard Make suitable for site.
- 1.2 Bidder should have valid PAN, GST Registration No. and supporting documents must be furnished along with the bid.
- 1.3 The average annual financial turnover of the bidder during preceding three financial years should be minimum Rs. 20 lacs. The bidder shall have to provide certified copies of audited balance sheet for these years.
- 1.4 The offer as per technical specification will only be considered.
