QUALIFYING REQUIREMENT

1. NIT No. 01(18-19) (Civil)

- 1.2 The bidder must have an experience of having successfully executed / completed the annual contract for similar nature works in any of the thermal power plant(s) / gas power plant(s)/ any process industries/any electrical utility/organization (as the case may be according to the nature of work) during last 7 years ending last day of the month previous to bid opening date.
