ORDER

Sub: Amendment in RVUN Travelling Allowance Rules, 1971.

In exercise of the powers conferred vide order No. 43 dated 29.11.2001, the CMD in consultation with Director (Finance) is pleased to adopt the GoR Orders dated 09.10.2015, 16.10.2015 and 18.05.2016. Accordingly, the following amendments are made in the RVUN Travelling Allowance Rules, 1971, namely:

In the said Rules;

(A) The existing Rule 31(1) (1-A) shall be substituted by the following:-

"31 (1) (1-A) "A retired Nigam employee who is summoned in a criminal case or a civil case to which Nigam is a party or in a departmental enquiry on behalf of the Nigam, to give evidence of the facts which came to his knowledge while discharging duties of the post shall be entitled to travelling allowance as for journey on tour on the basis of his status at the time of retirement. The payment of T.A. claim shall be made by the office from where he retired after attaching to his bill a certificate of attendance and non payment of T.A. claim issued by the court or other authority which summoned him."

(B) Also, the existing item No. 1 of remarks column of Appendix 'A' (Part-III) appended as Annexure-III with the rules shall be substituted by the following:-

"1.(a) Air travel in economy class/lower class can be done through any Airline.

(b) All air ticket booking shall be preferred directly with the airline or through official website of airline.

(c) Tickets may also be booked through authorized booking agencies. However, facilitation fee/ service charges to booking agency (by whatever nomenclature) which is not included in the tariff charged by the airline, shall not be reimbursed.

(d) Element of Service Tax, Education Cess or any other fee/cess charged by Government on air travel or booking of air tickets would be admissible for reimbursement to the individual officer."

(C) The existing item no. 4 (ii) of the remarks column of Appendix-'A' (Part-III) appended as Annexure-III with the Rules shall be deleted and the existing item 4(i) be renumbered as item No. 4.

(D) The words "All state Capitals in India (except Jaipur) including Delhi" appearing in item number (iii), column 3 (Ordinary Rates) of Appendix-'A' (Part-II) appended as Annexure-II shall be substituted by the words "All State Capitals in India (except Jaipur) including Delhi and places connected by air-services".

(E) In Appendix-'B' (II) i.e. 'DAILY ALLOWANCE RATES FOR BOARDING AND LODGING' appended as Annexure-V, column 2 and 3 shall be substituted by the following:-
