Subject:- Payment of various allowances to State Government Employees during the period from 01.01.2017 to 30.09.2017 drawing pay under Rajasthan Civil Services (Revised Pay) Rules, 2017.

The pay scales of State Government Employees were revised under Rajasthan Civil Services (Revised Pay) Rules, 2017 w.e.f. 01.10.2017. Subsequently these revised pay scales were made effective w.e.f. 01.01.2016 vide notification no. F. 15(1)FD/Rules/2017 dated 09.12.2017. Revision of pay scale w.e.f. 01.01.2016 to 31.12.2016 is on notional basis. The arrears for the period from 01.01.2017 to 30.09.2017 of revised pay scales and Dearness Allowance thereon is to be paid in the financial year 2018-19 in three installments.

The Non-Practicing Allowance admissible to Medical Officers, House Rent Allowance and Compensatory (City) Allowance of State Government Employees have been revised w.e.f. 01.10.2017 with the Rajasthan Civil Services (Revised Pay) Rules, 2017.


The queries are being raised that during the period from 01.01.2017 to 30.09.2017 at which rate payment of these allowances will be admissible. In this regard it is clarified that during the period from 01.01.2017 to 30.09.2017, the Non-Practicing Allowance, House Rent Allowance and Compensatory (City) Allowance already paid / admissible on the basis of basic pay in the existing pay scale is final.

The payment of these allowances during the period from 01.01.2017 to 30.09.2017 shall not be admissible with the revised pay scale admissible under Rajasthan Civil Services (Revised Pay) Rules, 2017. With the revised pay, Dearness Allowance will be admissible at the revised rates w.e.f. 01.01.2017

and onwards. The Non-Practicing Allowance, House Rent Allowance and Compensatory (City) Allowance paid during 01.01.2017 to 30.09.2017 shall not be admissible at revised rates with the revised pay under Rajasthan Civil Services (Revised Pay) Rules, 2017.


