5. Not be entertained and will be rejected out rightly.
6. The tender for works shall remain open for acceptance for the period of 120 days from the date of opening of pre-qualification / technical bid or up to such period as detailed out in tender document.
7. If any tenderer withdraws his tender prior to expiry of validity period as mentioned at S. No.5 or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the department, or fails to commence the work in the specified period! fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money/ security deposit and other action under agreement.
