3. 2. The contract should also include the work of Rail Track Maintenance including Maintenance of marshalling yard, unloading of coal rakes, Operation & Maintenance of Heavy Machinery such as Locomotives, Bulldozers, Loader, Excavator and weighbridges etc. Also bidder should have an experience of handling minimum 350 labours at a time for continuous period of one year in thermal power plants of unit size 195 MW or above of Govt./Semi Govt./PSU during last 07 years ending last day of the month previous to the date of issue of the NIT.

(a) Three contract of “similar works” each costing not less than Rs.4.664 Crore.

OR

(b) Two contract of “similar works” each costing not less than Rs. 5.83 Crore.

OR

(c) One contract of “similar works” costing not less than Rs. 9.328 Crore.

Similar Work” means: “Operation & Maintenance /Overhauling of Automated PLC based Coal Handling Plant” having wagon tippler and Stacker-Reclaimer in thermal power plant of unit size 195 MW or above and also handling minimum 350 labours at a time for continuous period of one

year in power plants of Govt. /Semi Govt./PSU. The work should also include Rail Track Maintenance including Maintenance of marshalling yard, unloading of coal rakes, Operation & Maintenance of weighbridges, Operation & Maintenance of Heavy Machinery such as Locomotives, Bulldozers, Loaders and Excavator etc.

The same shall be supported by documentary evidence issued by the owner.

NOTE:

- I) The word executed means that the bidder should have achieved the progress Specified in the QR even if the total contract has not completed/closed. Payment receipt document with reference to WO No. and date or work execution certificate with executed value and referred order no. & date from the Owner to this effect that the job to this extent has been done by the Bidder satisfactorily may also be considered as a proof of execution even if the work has not been completed in totality (subject to furnishing proof of executed value of work in the form of certified copies of RA Bills) or any relevant documents, which is sufficient to prove the works completed or to be completed.
The same shall be supported by documentary evidence issued by the owner.
- II) The above orders should be directly placed on the tenderer. Experience of Sub-letted work will not be considered.
3. The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labour license and class "A" electrical license. If any of the above presently is not available with them, then they will furnish an undertaking on Rs. 100/- Non judicial stamp paper duly attested by notary for submitting the same within one month from issue of LOI.

NOTE:-

- I) Any firm who have been directly or indirectly terminated/blacklisted in any thermal power plant across India for any reason whatsoever will not be considered eligible for participation in this tender for which an under taking on Rs. 100 NJ Stamp paper shall be furnished by the bidder. In case if it is found at any point of time that the undertaking given by them is not correct, in that case he will not be considered qualified or order awarded to them shall be terminated. The bidder shall also be black listed for all future contract of RVUN.
- II) Bidder shall produce all supporting documents (original / self-authenticated and attested by Public Notary) in respect of QR as asked in the NIT and an affidavit in original on a non-judicial stamp paper of Rs. 100.00 regarding genuineness of the declaration/information furnished by them and authenticity of the supporting documents being produced by them, within the same time frame.

TN-SC-16/2019-20 (Boiler)

Only those firms can participate, who possess the following pre-qualifying requirements and shall have to submit necessary documents along with tender.

1. **Financial QR:** - Average Annual Turnover (AAT) of the participating bidder during preceding three (03) financial years as on the date of techno-commercial bid opening, shall not be less than Rs. **3.81 Crores** . Other income shall not be considered for arriving at annual turnover.

Note:-Bidder shall submit/furnish duly certified audited balance sheet and profit & loss account statement/Annual report or duly certified certificate from practicing CA showing the details of Average Annual Turnover of proceeding three (03) financial years as on the date of techno-commercial bid opening, to adjudge Average Annual Turnover criteria.

2. **Technical QR:- The bidder should have executed the similar work in India during the preceding seven (07) years reckoned as on the date of techno commercial bid opening having:**
 - a. Executed value not less than **Rs 3.05 Crores** in a Single Contract.
OR
 - b. Executed value not less than Rs. 1.91 Crores in Two Contracts each.
OR
 - c. Executed value not less than Rs. 1.52 Crores in Three Contracts each.

Similar works means either of the following:

- (a) The bidder must have executed Complete maintenance Contract (Boiler, Turbine and Generator) of 660 MW station or above capacity for a period of One(01) years or more in a single contract or repeat contract in the preceding seven (07) years reckoned as on the date of techno-commercial bid opening. Repeat contract means even if original contract was awarded for smaller duration, if the same contract period is extended, the total duration shall include extended duration in addition to original contract duration for the purpose of evaluation.

OR

- (b) The bidder must have executed minimum two numbers Turbine overhauls {(High Pressure (HP) Turbine, Intermediate Pressure (IP) Turbine, Low Pressure (LP) Turbine}, Generator and Valves together or in split contracts, minimum two nos. Boiler overhauls of 250 MW or above capacity power plants in last seven (07) years reckoned as on the date of techno-commercial bid opening. For the purpose of evaluation, One overhaul of Turbine, Generator & its auxiliaries and one overhaul of Boiler and its auxiliaries put together and executed in any consecutive 12 months period shall be treated as One Contract even if these are executed as separate contracts.

OR

- (c) The bidder must have executed erection and commissioning of at least One unit (Boiler and Turbine and Generator) of 500MW or above in last 7 years in combined or separate contracts reckoned as on the date of techno-commercial bid opening. One unit comprises of Boiler and Turbine (HP, IP & LP) and Generator required for 500 MW (or more) unit capacity.

OR

- (d) OEM/OES of SG & its Auxiliaries Packages and TG & its Auxiliaries Package for Chhabra Supercritical Thermal Power Project (CSCTPP), Chhabra & Suratgarh Supercritical Thermal Power Project (SSCTPP), Suratgarh i.e. M/s L&T Limited, M/s BHEL shall be deemed /considered to have met Technical Criteria stipulated in qualifying Requirements of this work. However, in case they bid for the Tender, they shall have to qualify Financial Criteria stipulated in this Qualifying Requirements.

NOTE 1:

The word "executed" means the bidder should have achieved the criterion specified in QR, even if the total contract is not completed/closed. Payment receipt document with reference to WO No. and date of work execution certificate with executed value and referred order no. & date from the Owner to this effect that the job to this extent has been done by the Bidder satisfactorily may also be considered as a proof of execution even if the work has not been completed in totality (subject to furnishing proof of executed value of work in the form of certified copies of RA Bills) or any relevant documents, which is sufficient to prove the works completed or to be completed. - I) In case where audited results (Balance Sheets and Profit & Loss Statement) for the preceding three (03) financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.
- II) The above orders should be directly placed on the tenderer. Experience of Sub-letted work will not be considered.
- III) The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labor license & class "A" electrical license. If any of the above presently is not available with them, then they will have to furnish an undertaking to the effect that same shall be furnished within one month from issue of LOI.
- C. The bidder will have to register themselves on website <http://www.eproc.rajasthan.gov.in> for participating in this tender. For this purpose Digital Signature Certificate (DSC) have to be obtained from any agency approved by CCA. This DSC will be used to sign the bids submitted online by the bidder. Unsigned tenders will not be entertained and will be rejected outrightly.

- D. The tender for works shall remain open for acceptance for the period of 120 days from the date of opening of pre-qualification/ technical bid or up to such period as detailed out in tender document.
- E. If any tenderer withdraws his tender prior to expiry of validity period as mentioned at S. No. 5 or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the department, or fails to commence the work in the specified period/ fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money/ security deposit and other action under agreement. If there is strong justification of believing that the tenderer or his authorized has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited.

 - iii. Copies of work orders executed.
2. The Bidder must have an experience of having successfully executed /completed the contract for same/similar nature work i.e transportation of LDO/LSHS/HSD/HFO from any power plant/ Refinery/Depot of M/s BPCL/IOCL/HPCL to any Govt./PSU/Power plant/Private Industries during last 7 years ending last day of the month previous to bid opening date with either of the following executed value(s) of the contract(s):
